Any service calls that are caused by your operation, including tripped breakers, will be billed directly to you.

Upon acceptance, I must supply a certificate of insurance (for a minimum of \$1,000,000), naming Summerfest Arts Faire as an additional insured for the dates of the festival, and current food handler's permit and event permit from Bear River Health Department. I agree to cover the cost of all electrical work performed at the event that is a result of providing incomplete or inaccurate information to the event organizer. \_\_\_\_\_ (Initial)

I agree that I will not sell coffee, tea, water or soda or provide these items free with any food purchase. \_\_\_\_\_ (Initial)

It is the responsibility of the concessionaire to check out with a Summerfest staff member prior to vacating the premises on Saturday evening to ensure that the booth space has been left clean and in good condition. A walk-through will be conducted on Monday after Summerfest with the Tabernacle staff to assess any damage (grease stains, litter, damage to pavement and grass, etc.) and make arrangements for the concessionaire to cover any and all cleaning costs associated with the clean-up. The concessionaire will forfeit some or all of its deposit in such cases. The damage will be documented by photograph. Any expenses incurred will be billed directly to the concessionaire. Concessionaire

agrees to pay any cleaning costs that result from damage done to Tabernacle grounds as a result of their food service operation.

**Hold Harmless Agreement**
