## **2018 Plein Air Photography Contest: June 8-13, 2018**

**Professional Artist Registration Fee: \$25 (non-refundable)**

**Amateur Artist Registration Fee: \$5 (non-refundable)**

### **Dates for registration:**

June 8, 5pm-8pm; June 9, 8am-10am. St. John's Episcopal Church (85 E 100 N in back)

After June 9: By appointment at the Summerfest office (69 E 100 N). Call 435.213.3858 for appointment.

Photos must be taken in Cache County, Utah, and the sections of Cache Valley that are in Franklin and Bannock Counties in Idaho, up to Red Rock Pass. Maps are available online at [logansummerfest.com](http://logansummerfest.com) or at the Summerfest office (69 E 100 N). Original photos, including EXIF data, must be emailed to [info@logansummerfest.com](mailto:info@logansummerfest.com) by noon on Wednesday, June 13, to verify the date and time of the photo. Please include your last and first name in the filename of the emailed data. Be sure to allow time for printing and framing your photo—some of the local shops get swamped on Tuesday and Wednesday.

**Artwork Check-in:** Wednesday, June 13 from 10am to noon at the Summerfest Plein Air tent on the Logan LDS Tabernacle grounds (50 N Main). Entries must be ready for hanging (framed or finished edges, and wired for hanging). Each photographer may enter one photo.

**Welcome Reception & Awards Ceremony:** June 13 at 6pm in the Plein Air tent.

**Silent Auction:** June 13-16, 2018. All entries will be juried (June 13) and displayed in the Summerfest Plein Air tent starting June 13 at 6pm through June 16 at 6pm. Artists may choose whether to sell their work or not in the silent auction, but all entries will be displayed unless excluded for a rules violation. The artist sets the minimum bid amount as well as the "Buy It Now" price. All sales are subject to a 25% gallery fee and Utah sales tax (currently 6.6%). Please take this into consideration when pricing your artwork. The final call for bids will be at 6pm on Saturday, June 16. Summerfest will issue payments for all sold artwork no later than one month after June 16. Unsold work must be picked up at the Plein Air tent between 6:30pm and 8:30pm on Saturday (AND NOT BEFORE THEN). Items left with Summerfest for more than 30 days after the event will become the property of Summerfest and may be sold to help support Summerfest.
